## **BACKGROUND**

The treasurer is a statutory officer who is responsible for various duties under the Municipal Act. In the absence of a treasurer, these roles and responsibilities fall to the Deputy Treasurer, thereby prompting this report by the Deputy Treasurer to meet regulatory requirement deadlines.

## **ANALYSIS**

In accordance with Section 284 (1) of the Municipal Act, the Treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,

*(a) each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;*

Further, Section 284 of the Municipal Act 2001 states:

*“Despite the Municipal Freedom of Information and Protection of Privacy Act, statements provided under subsections (1) and (3) are public records.”*

It is the policy of the City of Elliot Lake to publish the Statement on our website in order to meet the public records requirement.
